PASTOR'S REPORT

January is the season for annual reports: the President will give the State of the Union address; the new Governor will be giving for of a “looking ahead” speech than a State of the State address; congregations large and small will have Annual Meetings in January and hear from pastors and councils how things are going ...sort of a State of the Church address. One way to give an annual report is with a calculator in hand. How many services did we have? How many people attended? How many outreach events and which organizations received our assistance? How much money did we give away? How much money did members donate to the church? Lots of “how much and how many” questions...but numbers don't really answer the question of what is the state of the congregation?

Our annual reports tell so much more than numbers! It is about love! And that can't be measured with a calculator. It is only measured by how we are living out our baptism. In the Affirmation of Baptism service we are called to do five things: live among God's faithful people; hear the word of God and share in the Lord's Supper; proclaim the good news in word and deed; serve all people; and strive for justice and peace. With this in mind, how would you give the state of the church address for St. Peter's by the Sea?

The waters of baptism flowed over the heads of three new Christians in 2018. Baptized at the font at St. Peter's by the Sea last year were Silas Gildorf, Sascha Fiore and Charlotte Young. Our Confirmation class doubled in size this past summer with Samantha O'Brian and Ian Smart joining Hannah Zimmermann and Maya Slaughter. They especially loved Confirmation Camp at Lutheran Glen and the farm there. We even got to see baby goats be born!

The Christ candle that is by the font and lighted during baptism, is moved to the front of the sanctuary and lighted during a funeral or memorial service. That visual connection reminds us to trust in the promise of eternal life. We moved that candle many times in 2018 as we remembered in memorial services this past year Elizabeth Sjukvist, Michele Stratton, Phillips Gausewitz, Violet Matson, Gerry Hoffner, Della Rockwell, Ronald Wisley and Alyce Hilke.

The Deacons of St. Peter's by the Sea continue to be such a blessing for the congregation. You can read more about them in this annual report. Early in the fall we welcomed Bishop Taylor to worship with us and preside over the consecration of Steve Silva and Greg Lommen and the renewal of promises from our other deacons, Joan Allton, Jennifer Smart, Nancy Aeling and Diane Sherwood.

ALL ARE WELCOME! On the last Sunday in 2018 we welcomed new members to walk with us into the new year. We exchanged promises of prayer and support with Patty Lewis, Susan Ritchey, Lynda Rowinski, and Jane Landon. We continue to find new ways to share our building and our faith life at St. Peter's. Youth and college groups, Interfaith Shelter Network, meetings and retreats for other congregations and organizations, YMCA exercise classes, Tai Chi, Al-Anon and more.

1. Loaves & Fishes. Collections were done in April and October. Water's Edge Faith Community is the distribution site.
2. Empty Bowls. This was held on May 20th. A brunch was sponsored by the committee. TACO (Third Avenue Charitable Organization) was this year's beneficiary.
3. The Church mice collected plastic cutlery, plastic bags and made quilts and school bags. 40 School Kits and 3 quilts were made and shipped to Lutheran World Relief via Lutheran Social Services of Southern California (LSS/SC).
4. Rosemary Sutter hosted the Angel Tree activities this year and many wonderful gifts were provided. 50 Angel gifts were given to children through Lutheran Border Concerns Ministry and 54 Angel gifts were given to children through the Hispanic Outreach program at Our Savior's Lutheran Church.
5. A number of Christian Service members organized St. Peter's hosting the Interfaith Shelter Network this year including Carolyn Irby, Sandra Boelter, Darlene Morrow-Truver, Rosemary Sutter and Ellen Schmeding.
6. The Christian Service committee assisted with the Easter Brunch.
7. The Women's Tea was held December 8th and was very well attended. Musical entertainment was provided by Pt. Loma Community Presbyterian Church bell ringers. Jane Christensen was our lead.

EDUCATION COMMITTEE

During this year, we continued using the "Whirl" curriculum for St. Peter's Sunday school classes. The curriculum coincides with the church liturgical readings which helps to reinforce the biblical messages for the children. During the summer months we returned to a one room classroom. We had a dedicated group of teachers again this year which included Laura Brown, Colleen Doering, Ellen Schmeding, Darlene Morrow-Truver, Terri Webster, John Smart, Deirdre Slaughter, and Liz Medina recently joined the group.

The annual children's Easter event was held March 31. We had close to 40 kids and their families. They participated in egg dying, cookie decorating, crafts, and an egg hunt followed by a pizza party.

Vacation Bible School (VBS) was held at St. Peter's July 23rd - 27th from 9:00 a.m. till noon. We had 40 kids participate in the God's Good Creation theme, which included opening and closing songs, Bible story time, imagination station, music, crafts, games, and snack time. Farm Animals from Lutheran Retreats, Camps, and Conferences (LRCC) came, to the delight of the students. In appreciation, VBS contributed money to LRCC for farm animal acquisition. A group of dedicated adult and youth helpers made VBS a colorful, fun-filled, and spirit filled week. The cost to run VBS was partially defrayed with a \$250 Thrivent action team card secured by Darlene Morrow-Truver.

Rally Sunday was held September 16th. St. Peter's youth participated in the many parts of the service, including ushering, singing, readings, skits, and a coffee-hour potluck. After church they enjoyed jumping in the bounce house, getting temporary tattoos, playing games, and collecting prizes.

The first of planned bi-monthly family fellowship dinners was held October 20th for families with children of Elementary and Middle School age.

The children's Christmas play, directed by Solveig Fuentes, was held December 16th. The theme was Crazy, Busy, Peaceful, Holy Night.

ENDOWMENT COMMITTEE

OVERVIEW

St. Peters by the Sea Lutheran Church's Endowment fund was established 38 years ago to enhance our congregation's mission outreach by sharing the love of God in our community. The funds generated are divided equally into 4 categories:

1. Missions and Programs - such as Third Avenue Charitable Organization (TACO), the Pacifica Synod, Lutheran Border Concerns Ministry, the Navajo Evangelical Lutheran Mission, and other Lutheran based programs.
2. Outreach - Programs or organizations that are not Lutheran based, like Loaves & Fishes (OBEF), Peninsula Shepherd Center, the San Diego Rescue Mission, Casa Cornelia Law Center and Mama's Kitchen.
3. Education – We support educational programs, such as Vacation Bible School and the confirmation program and camp, among others
4. Building - special projects and specific upgrades to the Church property such as repairs to the heating system and providing new financial software.

INVESTMENT

The Endowment Fund requires the committee to invest in investments that are conservative, safe, and generate a reasonable rate of return on the interest generated from the principal. To that end, we have invested with the Mission Investment Fund (a financial ministry of the ELCA that offers church building loans), the ELCA Endowment Fund and a Vanguard Balanced Index Fund

DISTRIBUTION

Endowment Fund directives require the committee to distribute the interest portion of the principal equally to the 4 categories listed above. Interest income this year ranged from approximately \$3,600 to \$3,775. Money not distributed is rolled over until the next quarter, and all monies were distributed this year.

ADMINISTRATIVE

Financial details are listed in the following report. The Endowment Fund continues to grow. As of the end of the third quarter of 2018, the principal fund balance was approximately \$508,000.00. We continue to use July as "Endowment Month", and this year we had speakers from Luther Glen, Mama's Kitchen and the Interfaith Shelter Network.

The committee – Nancy Aeling, Maggie Box, Richard Doering, Kathy Rahilly, Kendall Sandage and Scott Walls – is guided by God's presence in our work.



PRESCHOOL COMMITTEE

Preschool committee members for 2018 were Denise Langlois (Director), Kendall Sandage (parent representative), Pastor Marohn, Deirdre Encarnación Slaughter, and Darlene Morrow-Truver. Sally Brown served as a parent representative through August 2018.

As in previous years, enrollment is high. Demographic shifts due to the transitional kindergarten programs at local public schools have resulted in more students in the younger classrooms and fewer TK students.

Among the notable proceedings at the preschool this year:

- A new cell phone policy was enacted in March. Cell phones are no longer permitted in the classrooms, with phones stored in a basket in the break room. Cell phone use is now permitted only during breaks and never in the presence of children, even on breaks. One staff member will have a phone during field trips, walks, etc., for use only during emergencies.
- Two new aides were hired in March to replace outgoing staff.
- The preschool Spring Break was changed for 2019 to be closed on Maundy Thursday and be open on Easter Monday.
- Denise attended a “Director’s Bootcamp” in Dallas this summer.
- Three rooms had the air conditioning units replaced. A donated washer and dryer were installed (and subsequently repaired).
- New employee handbooks and letters of employment were completed. Letters of action will be used annually to update (instead of new contracts).
- Staff received a 2% raise across the board in September, future wage increases will follow the calendar year. Next raise to be given in January 2020, and might vary based on merit instead of all getting the same amount.
- The registration fee will be raised from \$50 to \$75 to offset increasing cost of supplies at start of school year. Tuition will continue to increase 2-2.5% each year.

Preschool events included Mother’s Day tea, teacher/staff appreciation week, Father’s Day lunch, pumpkin patch field trip, Thanksgiving program, and Christmas program. This year’s Christmas program will have the largest group in Denise’s 12 years at the preschool! We’re looking forward to another successful year.

Financial Review of St. Peter's Lutheran Church - Year 2017 Records

2017 Church Audit Committee: Greg Lommen, Bob Keck, and Allison Crews.

A review of procedures was conducted in the areas of Sunday Counters, Preschool Records, Church Records, and Endowment Fund.

Summary of Findings and Recommendations:

During the Sunday Count Review, proper procedures were followed including:

-Two Counters were present at all times, each Counter was assigned a preassigned duty and following the count, each person checked the work of the other Counter. Copies were made for their records, Financial Secretary and Church Treasurer. The computer software ensures a safe, reliable and easy to use format to account for incoming monies and also ensures that each account given due credit.

During the Review of Church Records, findings included:

-Two random months were selected and processed for review. We found that all bank accounts had been reconciled, deposits had been accounted for and checks were properly accounted with supporting receipts attached. Each month is accounted for to close out the books. To ensure that all accounts are credited and debited accordingly, notes were made on various bank statements.

During the Review of Preschool Records, our findings included:

-Two random teachers were chosen. First we looked at their written contracts that were signed at the beginning of the school year. Both were signed and correctly dated. We then checked two different months for their work sheets and paychecks. St. Peter's uses PayChex, an automatic paycheck service for all employees. All procedures were followed. During the Review of Endowment Funds, our findings included:

- Richard Doering, Financial Secretary for the Endowment Committee, provided an overview and financial records of the Endowment Fund. Endowment funds are held at US Bank, Mission Investment Fund, the ELCA Endowment Fund A, and with Vanguard Balanced Fund Index. Interest only is spent on four categories per the Constitution of St. Peter's by the Sea Endowment Fund and two signatures are required on each check.
