We elected a new bishop, Bishop Andy Taylor, in May of this year. God continues to bless us with a mission and with members to carry out God's work from this corner of Sunset Cliffs Blvd in San Diego.

With the approval of our 2017 budget in December, volunteers from the Council and congregation have agreed to review our current budget and financial obligations and will discuss how best to stay true to our mission to seek and share the love of Christ while ensuring we serve as effective stewards of our resources to help us meet this mission. OFFICE ADMINISTRATOR'S REPORT

The church office continues to be highly productive with Sunday worship bulletins, including a large print version; a monthly printing of the church newsletter, *The Fisherman's Net*; special seasonal printings; various projects throughout the year and annual printings including this Annual Report of the Congregation. Additionally, the office files annual reports with the ELCA (Congregation Report), Worker's Comp Audit, California State Board of Equalization and other regulatory offices.

This year, several contracts were renegotiated and/or renewed with savings to the church:

- ❖ Copier – a lease was signed with AIS for a refurbished copier with FAX and color printing options, resulting in annual savings of \$3900.00
- ❖ Worker's Comp Insurance – new policy through our payroll company, PayChex, with coverage provided by Hanover Insurance. This resulted in annual savings to the church of approximately \$1200.00 and will streamline end-of-year Worker's Comp audit process.
- ❖ AT&T Telephone and Internet – the Preschool's telephone line was incorporated into the church's billing, resulting in savings to the Preschool and church contract was renewed with savings to the church.
- ❖ Republic Services – our waste disposal contract was negotiated and renewed for three (3) years with locked-in, lower rate.

The Office Administrator continued with the responsibilities of Bookkeeper, previously incorporated in the duties of the volunteer Treasurer; attended several webinars to keep up-to-date with job responsibilities; attended a workshop sponsored by our payroll company regarding proposed changes to overtime rules; provided support to organizations who use/used our building site including: Peninsula YMCA, CoCoMotion Dance, Registrar of Voters, two Mission Trip groups, and PLNU department retreat. Additionally, office support was provided to a seminary intern and a Point Loma Nazarene University intern; each spending approximately three months with St. Peter's by the Sea.

The annual SDG&E inspection brought to our attention the need to replace the wall heater in the church office and needed repairs to Youth Room heaters. Solutions were researched and bids sought to address the needs of the church and pastor's offices as well as the upstairs Youth Room.

Weekly staff meetings were held between the Pastor, the Office Administrator and the Preschool Director, allowing us the opportunity to discuss and coordinate upcoming events and to support each other in our respective positions.

The office is supported by a Financial Secretary (Elaine Lauger) and an office substitute (Betty Wells.) I thank both of them for their contributions.

PROJECTS:

Empty Bowls/TACO: Coordinated by Lynn Render, the members of both St. Peter's and All Souls' Episcopal congregations, joined together on May 22, 2016 to worship together and sponsor the 'Empty Bowls' brunch and pottery sale. Monies from the sale of beautiful, hand-crafted pottery items were donated to support the Street Ministry of the First Lutheran Church (T.A.C.O.), which provides food, clothing, medical services and numerous other resources to homeless people in the downtown area of San Diego.

Church Mice: The Church Mice meet weekly on Tuesday mornings, from 9:30 a.m. to 12 noon in the Fellowship Hall to work on a variety of benevolent projects throughout the year. Besides crafting quilts and comforters for **Lutheran World Relief**, they wrap eating utensils for **Loaves and Fishes**, cut stamps and box tops for **local school fund raisers**, prepare back-to-school kits for the **Navajo Mission School**. The Church Mice also stock the sanctuary pews with envelopes, pencils, and hand sanitizer. During 2016, the regular attendees were: Dora Aja, Rose Engleman, Sue Fode, Elaine Lauger, Barbara Nielsen, Mary Miller, Debra Wiggans (Mary's caregiver). Janine Morrow, Pastor Karen Marohn and Betty Wells stopped by to visit and socialize.

Angel Tree Project: The Church and Preschool joined together to provide Christmas gifts to children through Lutheran Border Concerns Ministry and Our Savior's Lutheran Church in San Diego.

Homeless Outreach: Through this Committee and the combined efforts of other churches in the Ocean Beach/Pt. Loma/Pacific Beach communities, members of our congregation contributed blankets, scarves, hats, toiletry items, socks, lip balm, and food to the homeless in our neighborhoods on an ongoing basis.

Loaves and Fishes: Along with other congregations in the Ocean Beach/Pt. Loma area, St. Peter's supports this local food bank program, which operates out of the Episcopal Church Center. Many thanks to Sue and Bob Fode, who continue to commit their time and energy on behalf of the members of St. Peter's to collect and deliver much-needed food items during the months of April and October.

Lutheran Social Services: Many thanks to Christy and Ethan Gilsdorf, who continue to coordinate this bi-annual food drive for St. Peter's during the collection months of January and July.

EDUCATION COMMITTEE

During this year, we continued using the “Whirl” curriculum for St. Peter’s Sunday School classes. We held two classes (typically arranged by pre-K through 1st and 2nd through 5th) for the students during the majority of the year. The curriculum coincides with the Church liturgical readings which helps to reinforce the biblical messages for the children.

During the summer months, we returned to a one-room classroom strategy and elected to continue teaching during this time frame.

We had a dedicated group of teachers this year which included Colleen Doering, Sarah Leadley and Caleb Gilsdorf, Melissa Perez, John Smart, Deirdre Slaughter, Darlene Morrow-Truver, Ellen Schmeding, Terri Webster, and helpers which included Christina Doering, Ben Fadden, Evan Smart, and Maya Slaughter.

The annual children’s Easter event was held the day before Easter. We had a spirited group of about 30 kids who participated in activities which included egg and cookie decorating, crafts, and an egg hunt assisted by various St Peter’s members. A group of volunteers had previously stuffed about 400 plastic eggs with candy, toys, and stickers. The event culminated with a pizza party for the kids and their families, and the sanctuary decorating crew.

Vacation Bible School was organized by a dedicated group consisting of Darlene Morrow-Truver, Valerie and Jason Lawson, Melissa Perez, and Deirdre Slaughter. About 45 kids ranging in age from 4 to 7 years old attended the event, which was held July 18-22. The theme “Joseph in Egypt - from Prison to Palace” allowed St. Peter’s intern Tyler Marlow to showcase his excellent acting skills as Joseph, a special treat for the kids. The event was successful due to the many daily volunteers, which included St. Peter’s youth, and congregation and non-congregation adults who assisted with check-in and check-out, snacks, music, story time, and crafts.

Sunday School families and others participated again in this year’s Angel Tree project, purchasing gifts for kids whose Christmas will greatly benefit from their generosity.

The Sunday School children also continue opening the service with their enthusiastic singing led by Doris DeChenne. They also performed their Christmas play for the church on December 11th using our Narthex stairs as the stage for a second year. Solveig Fuentes was the director with help by Doris DeChenne, Deirdre Slaughter, and others. The event always caps our year with such a sweet, joyous energy and a chance to see our St. Peter’s kids in such a wonderfully meaningful way and is one of the highlights of our Christmas season.

ENDOWMENT COMMITTEE

The Endowment Committee is guided by Section C13.11.01 of the church constitution. The purpose of the Endowment Fund is “to enhance the mission outreach of the congregation apart from the general operation of the Congregation.” The committee is tasked to direct the investment of the fund principal and to distribute the resultant income.

This was the second year the committee took on July as a month to bring awareness to the Endowment fund and the great work that this fund allows our congregation to do in and around our community. The distribution of Endowment funds are divided into four separate categories. Each Sunday in July a committee member spoke about each of those categories - Mission and Program Grants, Outreach Grants, Education Grants, and Building Grants. We talked about the organizations in those areas that we support in serving our community. This campaign resulted in an increase to the principal thereby generating more interest for us to distribute.

INVESTMENT

The constitution requires the committee to “direct the investment of the principal of the Fund to investments that it deems best suited to earn a reasonable rate of return and that are consistent with the goals of the Fund, the congregation, and the duties of fiduciaries . . .” The committee feels that investment in “socially responsible” instruments is consistent with the goals of the congregation.

DISTRIBUTION

Income distributions are made to those in need equally in each of four categories as defined in the constitution: (1) Mission and Program Grants, (2) Outreach Grants, (3) Educational Grants, and (4) Building Grants. Any funds not distributed will roll over to the next quarter until the year-end when they are added to the principal. No rollover funds were added to the principal in 2016. The committee accepts written requests from church members for matching funds up to \$100. We were able to fulfill all 8 requests received this year.

ADMINISTRATIVE

Financial details in the attached report cover a full-year period starting with the fourth quarter of 2015 through the third quarter of 2016 because data for the fourth quarter of 2016 is not yet available.

Committee members serve a three-year term. The 2016 committee was composed of: John Smart, Chair (2016); Pete Fuentes (2016); Bob Fode (2017); Jane Christensen, Co-Recording Secretary (2017); Kathy Rahilly, Co-Recording Secretary (2018); Richard Doering, Financial Secretary (2018)

Pete Fuentes and John Smart completed their terms in 2016. We welcome Nancy Berner and Scott Walls to the committee in 2017. Officers will be elected at our January 2017 meeting.

For if you keep silence at such a time as this, relief and deliverance will rise for the Jews from another quarter, but you and your father's family will perish. Who knows? Perhaps you have come to royal dignity for just such a time as this.

As we look back--and forward--we should remember that perhaps God put us here, where we are now, with the challenges we find ourselves facing, because we have been called for such a time as this.

Opening with Questions

At our last meeting of 2015, we, like many of the congregation's committees, asked ourselves some questions, including "what is the purpose of the committee?" Fundamentally, our purpose is to let people know the church is here. There are people in our community who don't attend regularly, but to them St. Peter's by the Sea is still "my church." We try not to "keep silence" but to let people know that God welcomes them and we are here if they need us.

Summer Fest

Summer Fest (aka Fun Fest) made a return this year, in the form of a July church picnic at Liberty Station, with potluck dishes, several grills going strong, and an extra-large bounce house.

God's Work, Our Hands

This year, God's Work, Our Hands Sunday fell on 9/11, and many of the activities focused on first responders in honor of that fact, such as writing letters for single sailors, cooking a meal for the SWAT team, and preparing goodie bags for a fire station. On Saturday we worked with members of Calvary Lutheran Church in Solana Beach to sort clothes for the charity Doors of Change.

Blessing of the Animals

It is always a pleasure to work with other committees on Blessing of the Animals, and once again the event went well this year.

- A sign-out sheet for medical equipment in our storage area has been set up. Anyone needing to check out any of this equipment can see Betty Wells or Joan Allton.
- Blood pressure checks continue in the meeting room after church service on the last Sunday of each month.
- Ellen Schmeding presented a power-point presentation in March on Aging and Independent Services. She is available for any further information needed.

AUDIT COMMITTEE
Financial Review of St. Peter's Lutheran Church
Year 2015 Records

The 2016 Church Audit Committee, comprised of Greg Lommen, Robert Keck and Richard Nielsen performed the financial review of St. Peter's by the Sea for 2015. The work was completed in three parts beginning with the Sunday Counters, Preschool and then the Church records. The committee met with Preschool Director, Denise Langlois; church Office Administrator, Janine Morrow; and Pastor Karen Marohn during the audit process.

Summary of Finding / Recommendations

1. The Preschool uses software to track enrollment and tuition payments. The policies and procedures are also maintained on this software. We recommend that more reports be generated to assist Director and Preschool Committee for finances and personnel decisions.
2. Church financial records provided a clear picture of income and expenses. Church staff reviews contracts for insurance and services annually. A listing of renewal dates would insure proper review and bidding for upcoming contracts.
3. The church treasurer provides monthly reports to the Church Council to aid in financial decisions. The balancing of the bank account is done by the treasurer but we recommend that another individual also check the bank balance monthly.
4. The administration of employee benefits needs to be clear concerning annual vacation time, sick leave, and personal time. Perhaps a report could be prepared during January of each year. This report would include Pastor, Office Administrator, Health Ministries and Director of Music.

A Certification of Financial Compliance Review of Congregation Records was sent to the Pacifica Synod.
