## PASTOR'S REPORT

January is the season: the President is giving the State of the Union address; our Governor combined his inauguration with the State of the State address; congregations large and small are having Annual Meetings and hearing how things are going from pastors and councils...sort of a State of the Church address. One way to give an annual report is with a calculator in hand. How many services did we have? How many people attended? How many outreach events and organizations received our assistance? How much money did we give away? How much money did people donate to the church? Lots of "how much and how many" questions...but numbers don't really answer the question of what is the state of the congregation?

Our annual reports tell so much more than numbers! It is about love! And that can't be measured with a calculator. It is only measured by how we are living out our baptism. In the Affirmation of Baptism service we are called to do five things: to live among God's faithful people; to hear the word of God and share in the Lord's Supper; to proclaim the good news in word and deed; to serve all people; and to strive for justice and peace. With this in mind, how would you give the state of the church address for St. Peter's by the Sea?

The waters of baptism flowed over the heads of seven new Christians in 2014. There were several preschool siblings who were baptized at the celebration of this Sacrament on our Preschool Sunday last spring. Baptized at the font at St. Peter's by the Sea last year were Karter Hysko, Pearl Jackson, Kira Santoro, Lillianne Slaughter, Ian Helgeson, Nathanael Whitmore, and Kate Holohan. With the Affirmation of Baptism three of our teens were Confirmed this past All Saints Day. We were blessed by their sharing their faith statements on that day and continue to be blessed by the ministry of Christina Doering, Trent Webster and Elina Pepper.

The Christ candle that is by the font and lighted during baptism, is moved to the front of the sanctuary and lighted during a funeral or memorial service. That visual connection reminds us to trust in the promise of eternal life. We moved that candle only three times as we remembered in memorial services this past year Joan Doering, Eugene Kohr and Nicholas Berner. We also grieved the loss of several associate members this past year including Pastor Emeritus Dale Bringman, Jim and Lee Boyd and Gena Rasmussen.

The Deacons of St. Peter's by the Sea continue to be such a blessing for the congregation. Last spring we welcomed Bishop Finck to worship with us and preside over the consecration of Nancy Berner and Diane Sherwood and renewal of our other deacons, Joan Allton, Jennifer Smart and Donald Snowden. We bid a sorry farewell to Deacon Susan Benson who moved away from San Diego.

ALL ARE WELCOME: Renovation and Restoration continues into 2015. Do read that report and learn more about this! It was a challenge at times but we have been able to continue a full schedule of preschool and worship services throughout the construction. ALL ARE WELCOME continues to be our motto and ministry at St. Peter's!

Every time I place the stole around my neck I say a prayer of thanks to God for calling me to serve God as an ordained minister in the Church here at St. Peter's by the Sea. Thank you for calling me your pastor and sharing this wonderful ministry.

## PRESIDENT'S REPORT

This church would not have operated as smoothly without her hard work. This year was even a little more difficult with all the "All Are Welcome" campaign and expenses going out of that fund.

We are still very fortunate to have Janine Morrow and Elaine Lauger working hard for us in the church office. They are both very helpful and great with people. Janine is always willing to do whatever to help out. Our very successful preschool is still under the experienced leadership of Denise Duim. This preschool is a wonderful asset to our community and it has reached out to so many young parents with small children. An extra special thanks to all the teachers and aides who provide a quality education to these little angels!

Our youth ministry program was put on hold during this year due to the resignation of our Youth Director, Luke Williams, the renovation of the youth room (a project separate from the All Are Welcome project), and the resignation of our Youth Committee Chair, Keith Thygerson. The Youth room remodel was completed and during the church's construction, the space was put to good use by Sunday School, Congregation Council, Women's Book Study, AI-Anon, and other meetings.

Our church audit this year was done internally by our elected audit committee. The audit committee provides checks and balances necessary to running the parish. This job is time consuming and not always fun, but I thank all who are on this important committee.

Every week our worship experience is enhanced by the music of Doris DeChenne and the St. Peter's adult choir and children's choir. I want to thank her for all her hard work and direction.

## OFFICE ADMINISTRATOR'S REPORT

In 2014, we filed and received a "Small Business Health Care Tax Credit for Small Employers" for the calendar year 2013 in the amount of \$8869.84 (less than the 25% maximum allowed and with an 8% deduction due to the Federal Sequestration.)

**An excerpt from the IRS website:** *For tax years 2010 through 2013, . . . the maximum credit is 25 percent for small tax-exempt employers such as charities. An enhanced version of the credit will be effective beginning Jan. 1, 2014.*

The church office continues to be highly productive with Sunday worship bulletins, including a large print version; a monthly printing of the church newsletter, *The Fisherman's Net*; special seasonal printings; various projects throughout the year and annual printings including the Membership Directory and this Annual Report of the Congregation. Additionally, the office files annual reports with the ELCA (Congregation Report), Worker's Comp Audit, and California state.

In 2014, the Office Administrator accepted the additional responsibilities of Bookkeeper, previously incorporated in the duties of the volunteer Treasurer. Additional work was required due to the All Are Welcome Restoration and Renovation project; working with and around construction.

The city of San Diego did significant work on the city's water/sewage system in the community surrounding St. Peter's resulting in estimated water bills for a period of approximately one year. When major work was completed, the city's water department issued St. Peter's a credit based on actual usage. We used that credit for the last six months of 2014 with carryover to 2015.

Weekly staff meetings were held between the Pastor, the Office Administrator and the Preschool Director, allowing us the opportunity to discuss and coordinate upcoming events and to support each other in our respective positions.

The office is supported by a Financial Secretary (Elaine Lauger) who works 2 hours per week. The volunteer newsletter editor, Karen Thygerson, resigned due to her family's move and Christy Gilsdorf has taken on this important responsibility. I thank both of them for their creative contribution.

## **BUILDING FORUM**

### **All Our Welcome Renovation and Restoration Project**

October 2013 started with 63 pledges of over \$700,000 to proceed with our project. In light of this and funds on hand we started working with our architect to prepare plans for bidding. In late April we were prepared to seek contractor's to bid the project. The members met with the four proposed contractors in May after formal bids were received.

Watkins-Landmark Construction was selected at the end of May but final building permits were not approved until mid-June. The first weekend in June we organized the moving out of all kitchen items, furniture, etc. to the tool shed and forty-foot storage unit. The summer months began with demolition and the beginning of construction. THE BEGINNING!

St. Peters also applied for and received a Mission Investment Construction loan in the amount of up to \$500,000. As of this report we have not had to ask for any loan funds. We have used the funds on hand and the contributions received to make construction payments. We are very thank full to all who have given generously and will continue over the next two years..

Church services in the sanctuary continue, as we seem to figure how to overcome small problems with the help of the construction staff. Watkins- Landmark has always been aware of our church needs each Sunday. The entire congregation has the opportunity to see the progress made each week during construction.

The construction firm, pastor and some members meet every two weeks for updates. They have said that the substantial completion of construction is February. We are all looking forward to enjoying the new facilities.

## CHRISTIAN SERVICE COMMITTEE

**Annual Fund Raising Brunch:** The annual Christian Service Committee Brunch was held on Sunday, June 1, 2014. The Restoration and Renovation project at St. Peter's created the collaboration of this event with All Souls' Episcopal Church. This successful event raised \$2,090 through contributions and the sale of bowls made by local potters left over from the Empty Bowls fund raising event. An additional \$800 was received from Thrivent Financial for Lutherans "Care Abounds in Communities" program. A total of \$2,890 was sent to the Third Avenue Charitable Organization (TACO). Lynn and Ron Render and Pat McGregor were recognized for their continued coordination of this project.

**Church Mice:** The Church Mice continued to work on a flexible schedule at the home of Barbara Nielsen due to the Restoration and Renovation project. The committee members of Elaine Lauger, Rose Engleman, Dora Aja, Ethel Ratejesak collected plastic grocery bags and provided the plastic cutlery sets for Loaves and Fishes.

**Angel Tree Project:** The church and Preschool once again teamed up to provide gifts to children through Lutheran Border Concerns and Our Savior's Lutheran Church in San Diego. Bruce Wetherby and Bob Fode delivered 85 wrapped gifts generously donated by Preschool families and church members. Melinda Wetherby is once again recognized for her commitment to this project.

**Homeless Outreach:** This project took place once again at Christmas to help the homeless in Pacific Beach. Rose Engleman and Elaine Lauger made lovely reusable bags to fill with needed items. On December 7<sup>th</sup>, after church, over 100 bags were filled with blankets, socks, combs, water, granola bars, personal hygiene items, toothbrush, toothpaste, hand sanitizer, some hats, gloves, scarves, chap stick, and candy. Church members donated items. Thrivent Action Teams donated \$250. A total of \$659.53 was spent on purchasing items which came from the Thrivent donation along with monetary donations from church members. On December 11<sup>th</sup> the bags were delivered to homeless men and women at a feeding in Pacific Beach. They also received homemade cookies baked by Betty Wells and Melinda Wetherby. The bags were well received with deep gratitude.

**Loaves and Fishes:** St. Peter's is one of the Ocean Beach/Point Loma Churches that support this local food bank program. Sue and Bob Fode continue to commit their time and energy to collect and deliver for St. Peter's during the months of April and October. We thank you for your service!

**Lutheran Social Services:** Christy and Ethan Gilsdorf continue to coordinate the bi-annual food drive for St. Peter's during the collection months of January and July. Your service is gratefully appreciated!

**Women's Christmas Tea:** The Restoration and Renovation project led to the cancellation of this annual and it was greatly missed. However, plan to attend this wonderful holiday event next year!

## EDUCATION COMMITTEE

In April we offered an Easter program for the children of St. Peter’s, the preschool and the community. We made fun crafts, decorated cookies and hunted for eggs followed by pizza lunch with those who were decorating the church for Easter day. This is always a wonderful multi-generational event.

We teamed up with All Souls’ Episcopal Church for Vacation Bible School and were fortunate that they could host VBS at their site, due to our renovations. What is so exciting about our VBS is our outreach to the community. There were over 50 children participating.

We did not have our usual Christmas Program this year, but the children did sing on Christmas Eve at the 5:30 p.m. service. Rehearsals were held during Sunday School for several weeks prior.

## ENDOWMENT COMMITTEE

The Endowment Committee is guided by Section C13.11.01. of the church constitution. The purpose of the Endowment Fund is “to enhance the mission outreach of the congregation apart from the general operation of the Congregation.” The committee is tasked to direct the investment of the fund principal and to distribute the resultant income.



### INVESTMENT

The constitution requires the committee to “direct the investment of the principal of the Fund to investments that it deems best suited to earn a reasonable rate of return and that are consistent with the goals of the Fund, the congregation, and the duties of fiduciaries...” The committee feels that investment in “socially responsible” instruments is consistent with the goals of the congregation.



### DISTRIBUTION

Income distributions are made to those in need equally in each of four categories as defined in the constitution: (1) Mission and Program Grants, (2) Outreach Grants, (3) Educational Grants, and (4) Building Grants. Any funds not distributed will roll over to the next quarter until the year end when they are added to the principle. No rollover funds were added to the principle in 2014.

The committee accepts written requests from church members for matching funds up to \$100. We were able to fulfill all 18 requests received this year.



### ADMINISTRATIVE

Financial details in the attached report cover a full-year period starting with the fourth quarter of 2013 through the third quarter of 2014 because data for the fourth quarter of 2014 is not yet available.

For the quarter ending 12/31/13, there was a double entry of \$152.16 when the Financial Secretary reported the available funds for distribution that was just discovered in January 2015. When the Committee met in October 2014, not all income data was available, so only \$3,124.17 was distributed. When the Committee meets in January 2015, an adjustment of \$35.26 will be added to the available funds for distribution to account for these issues.

## **EVANGELISM COMMITTEE**

The Building Forum donated the industrial grade stove, slated for replacement in the church renovation. In October volunteers from LBCM and La Misión began and completed the project and Nick's Kitchen became a reality.

### Blessing of the Animals

The annual tradition of blessing dogs, cats and other family pets was held in October, and was well attended by church members and members of the community.

### Day of Service

We participated with members of Point Loma Presbyterian and other local congregations to take part in a Day of Service. People from Saint Peter's helped prepare food for the homeless and build picnic tables for a YMCA, among other projects.

### Military Outreach

We contacted a group called Chaplains Caring for Veterans and Families to consider ways that St. Peter's can reach out to the military community. While this project was not a priority in 2014, as we concentrated on Nick's Kitchen, we have kept current with the group's projects and plan to have more to offer once the renovation is complete and we can offer a meeting place for groups from various ships and the like.

### Service Sunday

St. Peter's actively participated in the ELCA's second annual day of service, putting our hands to God's work. We painted parking lot berms to make them more visible to patrons of a local restaurant, cleaned local alleys and streets, potted and delivered plants to the homebound and wrote Christmas cards to send to deployed military members.

### New Member

We welcomed Sue Fode to the Evangelism Committee and are very happy to have her experience and enthusiasm.

### Adopt a Street

We have contacted I Love A Clean San Diego to learn the procedure for committing to a quarterly street clean up that would include a designation of the street as adopted by St. Peter's by the Sea.

The Health and Wellness Committee met on a monthly schedule during 2014, provided informative health-related articles for the *Fisherman's Net* throughout the year, maintained the onsite AED device purchased in 2007, conducted blood pressure checks during Fellowship Hour on the last Sunday of each month until the start of the church renovation, and met other parishioner needs in areas of health and wellness.

- Betty Wells introduced a Yoga class- any level - to be offered by Mary Owen, a certified licensed mass/body work therapist. These were held at St. Peter's first and third Thursday (until construction prohibited) and offered as free will donations.
- A book/DVD/CD sale was held on Sunday March 9<sup>th</sup>. Proceeds were donated to St. Peter's fund for special needs through St. Joseph's Storehouse. Unsold books were donated to local charitable organizations. ## PRESCHOOL COMMITTEE

Again, I am pleased to report that St. Peter's Preschool is truly blessed to have our classrooms staffed with five talented and caring teachers, two teacher aides, and a dedicated director. Nathalia Flores teaches our 4/5-year olds in the Dolphin class; Bekah Mack teaches our 4-year olds in the Sea Lions; Chelsea Quade teaches our 3-year olds in the Sea Stars; Dori Hoadley teaches our 2/3-year olds in the Flying Fish; and Gabi Mendoza teaches our 2-year olds in the Otters. Our very capable aides are Jaime Moore (full time) and Kaena Peden (part time). Our Director, Denise Duim, is a seasoned leader in her eighth year at St. Peter's Preschool.

As of December 2014, there are 63 students attending St. Peter's Preschool with two openings on Monday/Wednesday/Friday and six openings on Tuesday/Thursday. The new Pre- K programs initiated in San Diego City Schools this fall have impacted our preschool's attendance to the extent that our population is much younger this year. In past years we have had at least two 4/5 - year old classes, and this year we have only one. Our graduating class this year (2015) will probably be about 12 students, as compared to 26 last year.

Pastor Marohn plays an active role in our program's twice-weekly Chapel Service where the children benefit from learning God's word and learning of His abundant love for us. The children sing songs and share Bible stories with the entire school in attendance.

### 2014 Highlights

1. The preschool Play Structure will need to be replaced in the next few years. This will cost between \$20,000 and \$35,000. Currently there is \$1,040 in the Preschool Trust Fund towards this purchase.
2. We have two new parent representatives on the Preschool Committee this year: Neena Kuzmich and Deirdre Slaughter.
3. A 3% increase in the tuition was approved for this school year (2014 - 2015). There is a 10% discount on tuition if the family is a church member, and a 10% discount on additional siblings. **We are still the least expensive preschool in our neighborhood.**
4. **Four** siblings of preschool children were baptized this year, as Pastor Karen and Denise continue to reach out to our families.
5. Our Spring Open House, Auction and Ice cream Sundae Station was on March 25th. It was well attended and very successful. The Auction raised \$548 for our Tuition Assistance Program.
6. The **all-school** Field Trips to the Zoo and the Pumpkin Patch were also big successes with many older and younger siblings in attendance.
7. Teacher Appreciation was celebrated the week of May 5-9.

8. Mother's Day Celebration was May 9th and was very well attended.
9. Graduation was May 30th. We graduated 26 students. The Social was held outside and was well attended. Natalia Flores put together lovely Yearbooks for our graduates.
10. Father's Day Lunch was June 13th.
11. St. Peter's Preschool participated in a Language Acquisition and Sound Recognition Lab (LASR) through UC San Diego.
12. St. Jude's Trike-a-Thon raised \$430.
13. The Thanksgiving program was held on November 26th with a performance by the students followed by a Social for all in attendance.
14. **"Holidays Around the World"** was the theme of the Christmas Program this year held on December 19th.

The Preschool Committee approved a 5% increase in pay for the teachers and the director with continued full benefits for this school year (2014 - 2015). We look forward to another exciting and productive year.

The Preschool Committee would like to ask for continued prayers for Nathalia Flores' one-year old daughter, Amelia, and Nathalia and her husband Ozzie, as they continue with treatments for Amelia's brain tumor.

**AUDIT COMMITTEE**  
January 1, 2013-December 31, 2013

The audit committee, tasked to review the financial books of St. Peters by the Sea Lutheran Church has completed their audit. Based on the audit work performed, the books and records were found to be materially accurate in all respect.

In addition, the following were noted:

- Appropriate procedures are in place governing key financial operations and are being complied with.
- Proper segregation of duties are in place for all key financial transactions are not being circumvented.
- Controls governing the congregations' investments and bank accounts are in place and operating as needed.
- Assets and liabilities recorded in the congregation's books and records are supported by independent documentation.
- All general ledger balances are appropriately reconciled to their underlying assets and liabilities.
- Expenses are appropriately approved and supported by the appropriate documentation.
- Controls over the payroll process are in place and operating as intended.
- An appropriate records retention policy is in place and being complied with.
- The appropriate data processing controls are in place and operating as intended.

Specifically, the following audit work was completed for St Peters by the Sea Lutheran Church:

The following items were reviewed:

- Bank and investment accounts
- Bank reconciliation for four months of the calendar year
- Reconciliation of donations given and matched to the general ledgers, including on-line giving
- Special gifts and accounting
- Disbursements, including signature control and electronic payments
- Four months of invoices, tracking each expense to original invoice and proper authorization
- Credit card purchases and vendor payment procedures were reviewed and reconciled for four months of the calendar year

- Records management and safeguarding of assets/documents
- Financial reporting
- Endowment Fund – Funds approved for disbursement were disbursed and checks were cleared
- Investment reports were incorporated correctly into the Financial Reports (four periods verified)

#### Summary and Recommendations:

- The audit committee commends the staff of St. Peters by the Sea for Outstanding Record keeping. There were no significant discrepancies.
- St Peters may want to consider changing the software used for record keeping. A review of the monthly treasurer documentation, although extremely complete, was difficult to track, particularly due to duplication within the report.
- There were some expenses that were unable to be tracked with supporting receipts. These included checks #8233 (\$92.35), #8387 (\$174.20) and #8374 (\$126.20). There were also online transfers of large sums of money (i.e. \$30,000) from one checking account to another for which no documentation was available. Why is money being moved from one checking account to another?
- The church is charge \$25.40 as a monthly service charge for electronic giving. This is an excessive charge for the number of members using the service
- We noted increased electronic payment of expenses as compared to the previous year. Again, we recommend moving as many expenses as possible to electronic payment, for ease of tracking and record keeping. Again, consider a software package which will allow easy tracking of electronic payments.
- Has the church considered Vendor “shopping”—putting out bids for monthly services, including cleaning, pest control, landscaping, insurance, etc. This should be done periodically to ensure the church is receiving the best possible value for contracted services
